Dear Mayor Hales,

I put a letter in the mail today (I guess it will go out on Thursday) with details about the spy situation for which I am requiring assistance and mediation.

I wanted to make sure to contact you immediately, however, because I believe that images/video/recordings are *still* being distributed, and it is EXTREMELY important to me that this be halted IMMEDIATELY. I am VERY concerned about people hacking any feeds or streams and/or taking screenshots and downloading these illegally obtained images to keep or distribute later. It worries me, because digital files are nearly impossible to secure, and those in control of these images seem to lack all ethics. If someone needs to be taken into custody - please do that. I have a feeling the police know exactly who is responsible. I am very upset about this crime.

If you are are not the right person to contact about this, please forward it to the correct person. The main thing is I do not want to be put in the position of

dealing with police, or anyone who will be forced to lie to me, or who will be hostile to me.

My email is severely compromised and very unreliable due to all the intense hacking I have experienced. I don't feel I can trust Google Gmail to keep my accounts secure, and I haven't found a good replacement for them. If you need to contact me, the best way is by mail, or phone:

I expect your office will receive my "snail mail" letter by Friday. I hope to get a call from your scheduler next week. I really want to make some progress on this issue which has affected me and my family so severely.

Dear Mayor Wheeler -

I have had problems with being tracked and attacked here in Portland for several years now. When I first tried to report the surveillance to police, they tried to have me locked up in a hospital. I don't know what is in my police records, but I suspect things have been falsified.

Meanwhile, I've been attacked with electromagnetic frequencies for many years now, and it's just getting worse and worse. I noticed the issue about five years ago. Using a radio frequency detector, I found that implants in my body are being used to create severe pain and disease.

When Charlie Hales was Mayor I tried to contact him at least three times, asking for a meeting and/or help to find a remedy to my situation. Nothing was done. (See attached files.) I also wrote to probably two different police chiefs here in Portland. As you can see from the attached correspondence, my primary complaint to Mayor Hales (and the police) had to do with the intrusive surveillance and human trafficking. This is mostly because I was concerned that a complaint about directed energy attacks would bring about accusations of me being "delusional" - as had happened several times (by people who most certainly know better). However, last October I purchased equipment with which I have been able to detect radio frequencies emanating from several locations inside my body (see: <https://youtu.be/mhMbD8mXIeg>) as well as in my apartment; I have been able to photograph inflammation directly related to torture from covertly placed non consensual implants; and I have many, many photos of marks and burns on my body from microwave weapons. Can you help me put an end to these brutal and unconstitutional assaults? They seem to involve local hospitals (as perpetrators), and they may also involve police. I'd be happy to speak with you in person if that is helpful as far as figuring out a solution.

Dear Mayor Hales,

On January 19 I discovered a shocking and terrifying crime against me and my family. It is a crime of espionage, including the manufacture and distribution of images from inside our bedrooms and bathrooms; long-term severe blacklisting and string-pulling against us professionally; and severe intellectual property theft. This is clearly connected to my fiancée whom I believe has been abused in this fashion for more than three decades.

In my case, and in the case of my daughter who turned 18 last December (2013), I have several pieces of evidence telling me that this crime has been going on against us since February 2009. Five and a half years. I am outraged. This is a real and severe crime being committed against me and my family, and it continues today because those who know about it, and who have the ability to stop it, have not stepped in to stop it. In order to achieve justice, I need the city government – or the state government, or federal government -- to uphold my rights.

The home where all this happened is now on the market. If the police are NOT part of this crime, I would like to formally report the crime before the home is sold. Evidence is largely, but not entirely circumstantial. At the location, I can describe the overall gist of what happened, point to places where I believe cameras have been located, name names, show where my cheap RF detector picked up hot spots, etc.

The amount of circumstantial evidence is so tremendous, the truth should be undeniable to anyone who spends enough time paying honest attention. But I also have a computer hard drive with spy ware, a narrative of key events, and a broken code of symbols which I've been writing about here: <http://www.seastorm.com/writing>.

I need to speak with an investigator or official who has intelligence and patience, and who isn't going to bully me or push me around. I need to figure out how to protect myself and my family, and how to pursue justice

Here is the history of my interactions with police so far:

It was on January 20 (Martin Luther King Day) when I attempted to report the crime of espionage to police. I met with an officer named DeLong. He was accompanied by a female officer who stayed in the background. Not only did Officer DeLong refuse to take a report, he refused to examine my computer for evidence, and gave me very little time and opportunity to explain a complex and very

upsetting crime, instead aggressively questioning my sanity. He asked me to go to Adventist Hospital and interview with a doctor, saying that he would take the report afterwards. Now I believe he never had any intention of taking a report either before or after the hospital visit.

At Adventist Hospital, they asked me a few questions, and when I refused to give fluids (they wanted urine *and* blood), they attempted to put me on an involuntary lockdown. When I demanded to know why they would do that, and begged them to let me go home to my family who was waiting for dinner, they relented. This was basically an attempted kidnapping. A week later I was kidnapped out of a private home by firemen and sheriffs, though fortunately (for our purposes) that event did not occur in Oregon.

I found evidence that one of the people who I believe to be DIRECTLY involved in crimes against me, Tobi Vail of Olympia Washington, was "somehow" tracking my moves, and I found evidence pointing to her having set up this sketchy situation with Officer DeLong. I learned that DeLong has a prior connection to her and to her sister Maggie Vail of Portland via his uncle who was on their label, Kill Rock Stars.

Perhaps related, I have seen evidence pointing to the police being involved. Not only that, but I have seen signs that Portland Metro, Portland Fire Department, Tri-Met, and Northwest Natural Gas are complicit. And in the case of the latter, maybe instigators. This is really disturbing. It makes me think the entire city government of Portland has been involved in this crime. If so, I am utterly, completely shocked, astounded, hurt, and terrified. What about our civil rights? Can't we come to a resolution of some kind that works for everyone?

Some terrible things were done to me after my unfortunate encounter with Officer DeLong. I experienced thefts, vehicular sabotage, and lots of mobbing. I am still being tracked regularly and at times very obviously by people with cell phones, because no one will do anything to stop it, or to stop the person or people behind it.

In early February, for 11 days straight police (and maybe others) tormented me by running sirens over a dozen times a day near my home. While this behavior eventually stopped, the message got through loud and clear: they will not protect me from these crimes, but they will protect the perpetrators.

The end result of this is that I continued to be – and signs show that I continue to be – abused. The spying and broadcasting has continued for MONTHS after it could have been stopped, had anyone stepped up to protect me when I first asked. The spying may well continue to this very day, being as it was done in an extremely sophisticated and well-funded manner, and still no one is stopping it. Even after it ultimately ends, these criminals have five year's worth of illegally obtained recordings of my family's life which they continue to abuse, not to mention three and a half decades out of Chris' life.

It includes footage of my underage teen daughter and confidential medical information of all of us. Can you even imagine what this feels like? I need it to stop.

It's clear that many people are "addicted" to this footage. So there is pressure on having this crime continue in some form or another. As long as no one is held accountable, it will continue. I need it to end, and I need people held accountable.

I originally traced the problem to Mark Arm (McLaughlin) of the band Mudhoney (but funded from elsewhere) but for months, no one around him responded to these accusations. Finally, this past Monday, his employer responded to a tweet and pointed the finger at him. His partner, Steve Turner, lives here in Portland. There are connections to Olympia, Washington as well: Tobi Vail, Maggie Vail, and Calvin Johnson.

I hope you will help protect our civil rights.

UPDATE: 8/25/2014

Based on several pieces of evidence, I am almost certain that the surveillance is continuing today at my new address. The group-stalking also continues, albeit at a fairly subtle level, most of the time. Nonetheless, it's enough to let me know I'm still being watched.

To make things even more ridiculous, this crime is even coded into the mural next to the Portland Police station at 47th and Burnside, as well as into at least two other murals in SE Portland. Our privacy and civil rights are NOT being respected. PLEASE MAKE THIS HORRIBLE CRIME STOP. Please help us get justice.

People who need to be investigated: Mark Arm (Seattle); Bruce Pavitt (Orcas Island); Calvin Johnson (Olympia); Tobi Vail (Olympia); Steve Turner (Portland); Maggie Vail (Portland); and all top brass at Sub Pop records (they are blaming MARK ARM aka Mark McLaughlin).

Dear Mayor Hales:

This is a follow up to the meeting requests I submitted – one in person yesterday, and one online a couple of weeks ago. Due to what appears to be ongoing distribution of images/recordings taken by devices placed illegally inside my home, crowd-stalking, and computer and email security breaches, this situation feels extremely urgent and I've had a terrible time getting it resolved.

Apologies in advance if I seem to repeat myself – I've been trying to resolve this for so long now, I feel like a broken record. I hope that we can change this inertia, and soon.

I need help mediating and resolve this spying and intellectual theft situation which I attempted to report to Portland Police last MLK Day (1/20/14). I now very much believe that Police and other government agencies were directly involved, but I can't understand why. I need to know the gist of what happened, how 40 years (40 years in Chris' case – 5 years in my case) of illicit images and recordings were, and continue to be, managed and controlled, whether downloads ever made available anywhere, what is being done to remedy the problem now, and what process we need to go through in order to receive just compensation from those who manufactured, distributed and/or accessed these images and recordings without our knowledge or permission.

If you or anyone else have already taken action to help and protect us - thank you. I deeply appreciate it. However, it is very difficult to know exactly what is going on, and that is part of my problem. I am very concerned about this due to the duplicitous nature of my opponent and the general ease of stealing, reproducing, and re-distributing digital files.

If my apartment has been bugged with the city, state, or federal government's tacit or explicit approval, and unless there is an excellent reason for us to be watched by the government, corporations, and various industries, **the appropriate government agency should help us debug.** (This would *not* be the police, sheriff, or fire department.) I certainly can't imagine any good reason for us to be watched by the half the world as we seem to have been. If for some reason this surveillance has been deemed necessary on some level because we are a national security threat, I'd like to find out why we were so deemed, and what I can do to change that. Even then, I don't understand why these images were so widely distributed. **I do believe that Calvin Johnson, Tobi Vail (both of Olympia), and Mark Arm (Seattle) were among those directly responsible for gathering, editing, and distributing the images.**

Aside from the general offensiveness and psychological torture of this, the blacklisting is and has been a serious problem for me. I have no income, and no prospects. Some men leer at me on the street and/or continue to stalk me with phones. Meanwhile, I have heard my bedroom conversations and activities repeated and referred to in local publications and on national television several times, most recently on the Jimmy Kimmel show less than a month ago. *Update: happened again today 9/25!*

I think under the circumstances, it is appropriate for an elected government official to help mediate, or initiate mediation, and quickly. It seems pretty clear that the feds have been aware of this situation, and that the trauma-based "medical" treatments I received in California were somehow connected to research developed from CIA Project MK ULTRA. So there is clearly a lot going on here. **It certainly is attempted "mind control" to assert that those in my household present some kind of exception to international human and U.S. first amendment and civil rights laws, and to expect me - or anyone - to accept such an assertion.** Chris' mind has been well-controlled, sadly. Still, I am pretty sure even this does not except him from international human rights laws.

I believe that my attempts at bettering myself socially, professionally, and economically have been deliberately sabotaged several times over the past five years via various string-pulling manipulations. I can hardly afford this. I have some recurring disability issues (chronic pain flare ups) but well beyond that, my professional fields of writing, music, and media design are all fields where everyone seems to have been exposed to the illicit recordings, photos, etc. broadcast from my home and street. This is incredibly disheartening. I don't understand why I have been treated this way.

I don't even know what was broadcast, exactly, and to whom. This is very disconcerting. I just know that it involved images from my bathroom (including my toilet), my bedroom, my teenage daughter's

bedroom and bathroom, my computer hard drive, and all my confidential medical information. And that all these things have been the subject of coded ridicule for a very long time. I know that everyone who writes for any newspaper, does graphic design, owns a business, etc. seems to have had access to my life.

At this point, I feel professionally, financially, and socially stranded. Aside from that, I am concerned about my safety and my daughter's safety, physically as well as psychologically and professionally. I believe that many of the more egregious and inappropriate things that occurred, occurred specifically because certain individuals or groups believed - perhaps correctly - that they were operating above or beyond the law. If it is true, I definitely need an explanation, or preferably, I need them held accountable. I also believe there was a profit motive dating back the full 40 years as is indicated by the scene where a boy in India "sells the elephant" in the 1974 James Bond movie "Man With The Golden Gun."

I understand that there may be "good" reasons this very old-fashioned "game" was carried on for as long into modern times as it was. But the specific way it's being conducted seems cruel, disgusting, deviant, and dangerous. Those in control of the illicit footage clearly wanted to use it to manipulate my behavior, and when I didn't do what they wanted, attempted to use the recordings to psychologically, socially, and professionally destroy me. I already asked for them to be investigated, and I would like to if it has been followed up on, and if so, what is the status of that investigation. Unless they are decisively stopped from doing so, I believe that this cartel will continue to carry out actions against us. Similarly, if the blacklisting isn't actively and decisively turned around, it will never end.

I was the head of my household when California sheriffs kidnapped and held me last January. Even being locked up for those five days did severe damage, especially with what happened to my car and savings account in the process. (I can list at least three ways the 5150 detention was illegal, and I have printed a narrative and kept all associated paperwork.)

Also very important: **I need someone to carefully but plainly tell Chris the truth.** Find an appropriate way to do it, and do it quickly. The lack of honesty from everyone around us is extremely stressful and isolating. People I thought were friends turned out to be duplicitous in an intricately manipulated situation. Psychologically blinding and socially binding a person as we have been, is very cruel and dangerous – it's like trying to navigate the wilderness on crutches and in a blindfold. I think we deserve some honesty and protection from our elected officials at the very least.

My car, music, and professional reputation have been ruined by sabotage and blacklisting. I've been lied to by friends, family, doctors, journalists, my (now former) lawyer, police. Meanwhile, I have no money, no income for the past two years, no job, no access to legal help. I am professionally drowning because my civil liberties have been trampled for five years straight, and after almost a year of fighting against it to the best of my ability, there seems to be no end in sight.

Because this situation is clearly known to my government, and may well have been facilitated by the government, I think it is appropriate for the government to help protect us as citizens. **We need to learn the truth and achieve a fair resolution which involves a decisive and complete destruction of all illegally obtained images and recordings, accountability from the perpetrators, and just compensation for what we have suffered.** Chris has been buried and exploited for 40 years, but now at 61 he is still healthy enough to continue recording and performing, if we could just resolve this in time. He is a fantastic artist and musical genius who truly deserves to be heard, and to be able to professionally and socially interact with other artists. **We don't have forever.**

This could potentially be very easy to fix. The perpetrators clearly include the wealthiest humans and corporations on the planet, from pharmaceutical companies to Wall Street banks. They can easily make the necessary changes and amends, whether they "want" to or not. Is it not a matter of simply standing up for what is right and legal, against what is wrong and illegal? We're all in the middle of this mess, whether by choice, necessity, inheritance, or proximity. I am not interested in being "judged" by those who created this situation. I am interested in seeing THEM judged according to the applicable laws.

I need my elected representatives to show courage and willingness to stand up and do what is right in this very unusual situation. I still want to achieve an amicable resolution. I need assistance in the form of information, protection, and mediation, and I need it as soon as possible.

Please meet with me. Please help us. Thank you.

Dear Mayor Hales,

I would like to respectfully request that the City of Portland assist me, as soon as possible, with locating and removing the cameras and recording devices which are clearly still broadcasting from my apartment (and phone), and which I believe are being monitored by Portland Police Department and dangerous, unscrupulous members of the health care industry, among others. If you cannot, or will not, help me remove or disable these devices, then I ask that you immediately show me a legal basis for this surveillance, and explain why it does not violate the constitutional rights of me and my family.

The surveillance which I have been complaining about for over a year now is clearly still going on, and being very widely broadcast, leading to mob-stalking each and every time I leave my apartment. The pressure of this surveillance and the associated stalking, are, and have been, preventing me from having a normal healthy home life alone, or with my family, causing me to be blacklisted, and may also be putting me or my family in physical or other types of danger. I have repeatedly been the subject of threatening behavior from several powerful entities (including, but not limited to, members of the Police Department) who perhaps don't like the way I behave behind the walls of my own home. How can this possibly be acceptable *anywhere* in the United States of America?

In the case of my partner, Chris Newman, he brings his phone to confidential counseling appointments, etc, thus unwittingly exposing all kinds of confidential data to the world at large. My daughter may be doing the same thing. In my case, my most confidential medical records have been exposed to an extremely large group of people, many of whom are hostile toward me. These are HIPAA violations which I consider extremely severe and damaging, and the worst of it happened *after* I had asked for your help, in writing, at least twice. Information been gained through this illegal surveillance and is regularly used by people to bait and mock me on the streets, in the papers, and today, even inside the walls of City Hall.

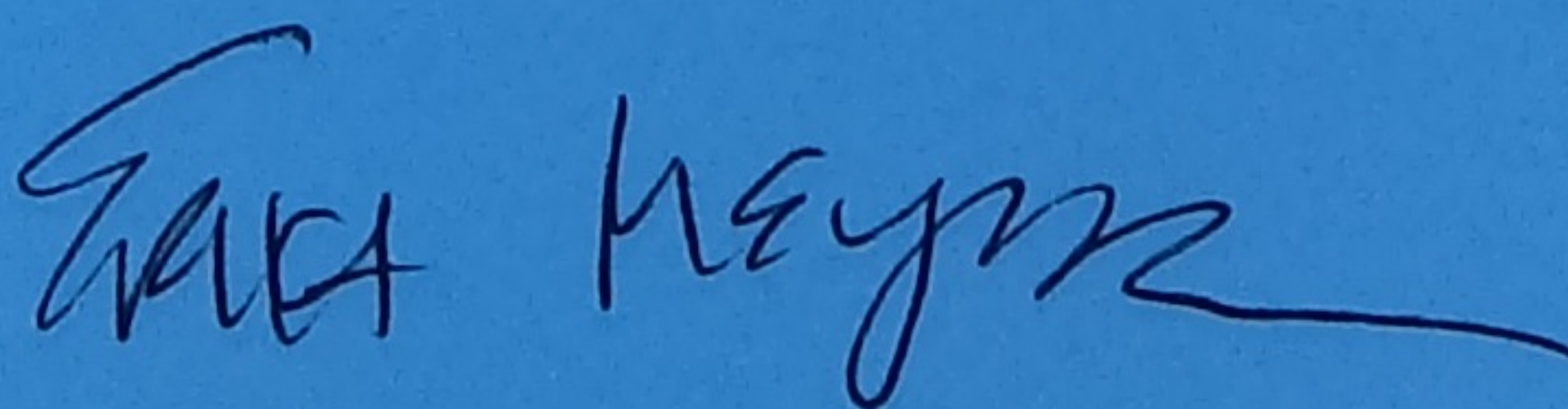
This surveillance violates *most* of the 30 articles on The Universal Declaration of Human Rights which was ratified by the United States along with scores of other nations in 1948. In addition it violates Amendments 1, 4, 5, 6, 8, 13, 14 of the U.S. Constitution Bill of Rights, as well as my and my family's HIPAA privacy rights.

By continuing to turn a blind eye to this surveillance and broadcasting, and/or participating in it, the City of Portland is exposing me and my family to constant pressure, trauma, and danger. I believe that it creates a larger hostile environment which negatively affects other members of the community as well. That is why I am asking for you to take action *today* on our behalf, and on behalf of the community at large.

I simply don't see any way forward towards real justice until there is a showing of good faith on behalf of the City government. Ending the illegal surveillance – especially the widespread broadcasting of our private lives to millions of strangers -- would qualify, in my mind, as a good faith effort. It would allow us to relax, to BREATHE, and to *finally* move towards a redressing past wrongs.

Thank you for what I hope will be your immediate attention to this extremely pressing and very important matter. I am enclosing an SASE for your convenience. *Please* take this request seriously.

Dear Mayor Wheeler,

I have written to you in the past regarding microwave attacks I experienced for an extended period last year - and I was very happy that after I wrote to you a couple of times, the worst of the attacks ended. They were very bad attacks, and I suspect they were coming from Portland Police or people protected by the police, through drones and possibly antennas. My situation is complex, and I've tried my best to explain what I know and how I know it through youtube videos (here is my channel <https://www.youtube.com/channel/UCsRIUHP-Kfj7Sa76raHOviA>), affidavits, etc, any or all of which i can provide, if you have questions. I know I've suggested meeting face to face with you (and with the previous Mayor) and I still think this would be ideal. But most important is the attacks stop. I don't think the attacks will stop unless someone stops the people behind them.

Rather than try to explain a very complex situation in an email, I really would like to meet with you. I would also like to invite you to look at my Twitter feed where I've described some of these issues: <https://twitter.com/erikakmeyer> - I tried to report a crime to Portland Police on January 20, 2018 and they responded by attempting to have me medically sectioned - the doctors lied in their paperwork, and likely also the police (I've never seen my police records). At the time, I named some of the people involved in the crime, and law enforcement in both Oregon and California consistently failed to write down the names I gave them. Portland Police refused to even take a report, and the only reason any paperwork exists at all is because in the end, I was medically sectioned based on lies told by my mother. I know for a fact my mother has told at least two major lies to police or related authorities about me, once claiming I was a danger to myself, and another time claiming that I was assaulting her. All of this was obviously intended to intimidate me into silence, and avoid holding the criminals accountable. The result is, the crimes have gotten more and more brazen. I believe the individuals listed below, with generous funding from vested interests, intend to murder Chris Newman and frame it as a medical event or overdose, and that the corruption is so deep in this, that they will have no trouble at all falsifying whatever documents they need to falsify. Again, I have already run into NUMEROUS instances of falsified medical and law enforcement records. That is why it so important that the people I've listed are investigated, as I believe they are contact points regarding the planning and financing of these incidents.

I have reason to believe that in addition to planning the murder of Chris Newman, the following individuals were directly involved in the deaths of Kurt Cobain, Elliott Smith, and others: **Bruce Pavitt, Tabitha (Tobi) Vail, Kathleen Hanna, Mark (Arm) McLoughlin, Calvin Johnson, Phil M Payne, Michael Brian Payne, Michael Allen Patton**. Except for Mike Patton and Kathleen Hanna, of these people live in Washington State.

Chris Newman is a very important person to Portland, whether you want to admit it or not. I don't think you should stand back and let these criminals murder him, no matter how powerful they are, or how upstanding they appear.

Please let me know if you have any questions, would like to see additional evidence, etc. This is a serious matter.

My situation is complex, and I've tried my best to explain what I know and how I know it through youtube videos (here is my channel <https://www.youtube.com/channel/UCsRIUHP-Kfj7Sa76raHOviA>), affidavits, etc, any or all of which i can provide, if you have questions. I know I've suggested meeting face to face with you (and with the previous Mayor) and I still think this would be ideal. But most important is the attacks stop. I don't think the attacks will stop unless someone stops the people behind them.

Rather than try to explain a very complex situation in an email, I really would like to meet with you. I would also like to invite you to look at my Twitter feed where I've described some of these issues: <https://twitter.com/erikakmeyer> - I tried to report a crime to Portland Police on January 20, 2018 and they responded by attempting to have me medically sectioned - the doctors lied in their paperwork, and likely also the police (I've never seen my police records). At the time, I named some of the people involved in the crime, and law enforcement in both Oregon and California consistently failed to write down the names I gave them. Portland Police refused to even take a report, and the only reason any paperwork exists at all is because in the end, I was medically sectioned based on lies told by my mother. I know for a fact my mother has told at least two major lies to police or related authorities about me, once claiming I was a danger to myself, and another time claiming that I was assaulting her. All of this was obviously intended to intimidate me into silence, and avoid holding the criminals accountable. The result is, the crimes have gotten more and more brazen. I believe the individuals listed below, with generous funding from vested interests, intend to murder Chris Newman and frame it as a medical event or overdose, and that the corruption is so deep in this, that they will have no trouble at all falsifying whatever documents they need to falsify. Again, I have already run into NUMEROUS instances of falsified medical and law enforcement records. That is why it so so important that the people I've listed are investigated, as I believe they are contact points regarding the planning and financing of these incidents.

I have reason to believe that in addition to planning the murder of Chris Newman, the following individuals were directly involved in the deaths of Kurt Cobain, Elliott Smith, and others: **Bruce Pavitt, Tabitha (Tobi) Vail, Kathleen Hanna, Mark (Arm) McLoughlin, Calvin Johnson, Phil M Payne, Michael Brian Payne, Michael Allen Patton**. Except for Mike Patton and Kathleen Hanna, of these people live in Washington State.

Chris Newman is a very important person to Portland, whether you want to admit it or not. I don't think you should stand back and let these criminals murder him, no matter how powerful they are, or how upstanding they appear.
