Below is the email from PCC Public Safety Director Derrick Foxworth "on behalf of Leslie Riester" in reply to the computer surveillance portion of my informal Title IX complaint.

I had made the Title IX complaint orally while the PCC Title IX staff took notes. They must have later contacted Foxworth or Riester while investigating my complaints. I had tried to be clear that what I was experiencing was surveillance and interference (not likely "hacking") . Although I was already aware I was also being watched in the women's restrooms, I had not made that complaint yet, out of concern that it wouldn't be taken seriously and that I would be retaliated against more severely.

I followed up with a handwritten note to Title IX, probably in the first week of June 2015 (it was probably right at the end of Spring term - the Title IX team was in Washington D.C.). In the handwritten note I mentioned the surveillance in the restrooms, and asked for the cameras to be removed.
