On Feb 15 I sent you an email with an attached letter in PDF format. I wrote and sent the letter quickly because the situation has been very intense and we are in danger I felt it was important to get the message out as soon as possible. Over the past three days I've been able to refine the letter and add more supporting details, including some records and affidavits I put together over the past several years. I am sending you now this revised letter, and the relevant attachments.

20210218_OSC_letter - the main letter, includes list of violations of law, constitution

UDHR_violations - list of UDHR article violations

2014-01-20_adventist_affidavit - related to defamation in medical records for the purposes of discrediting me

2014-02-03_ohsu_pollack_affidavit - also related to defamation in medical records for the purposes of discrediting me

2017-04_bed_bugs - an example of a biological attack in the form of planted bed bugs, also includes some other linked events including a "stinging fly" and a laser slice out of thin air (I've experienced many burns and a few "slices" of the top layer of skin coming from thin air)

I hope the letter explains the rest. I can provide more documentation as needed.
