Mar 29 2022 8:07AM Per OHS Report: Owner refuses to continue taking her to the vet because she believes the vet is part of a huge conspiracy to kill her. She has an entire youtube channel that I've been keeping an eye on and someone asked her about her cat and she explains the general history of her vet visits from minutes 24 to 31 in this video: <https://www.youtube.com/watch?v=IrfZMt43dM>. she said herself that flea medication helped in the past, and that she was recommended a dermatologist because of how bad the cat's skin condition is, but she is refusing to take her now. Roxie (the cat) appears to have ear infections again and is missing fur from itching. It looks like possible ear mites but I'm not sure, she could just have irritated ears, but she has scratched them until they bleed.

Mar 29 2022 12:35PM 03.29.22 approx 1200 I arrived at 305 NE 61st ave. I walked around the complex and a neighbor informed me that D13 may be a basement unit and could be accessed at the back of the building. I walked to the door that leads into D13 and D14 and it was locked. I knocked on the door several times and there was no answer. I walked to the window that may be for D13 and lightly tapped on the glass to see if anyone was home. I could see inside the unit and the lights were turned off and no one appeared to be home. I left a card in the door requesting a call back. I watched the video provided by the PR of the Youtube live stream and the cat owner starts talking about the cat starting at 23.11. The cat owner shows pictures of skin marks and scratches inside the cat's ears and on the skin. The cat owner states she has taken the cat to the vet several times and has been diagnosed as a flea/skin allergy. The cat owner states that the cat got better for awhile before flaring up again. The cat owner stated that "directed energy" was harming her cat, thus causing the cat to harm and scratch itself. The cat owner does not state her way of helping the cat but stated that she does not trust the vet anymore.

Mar 30 2022 3:28PM 03.30.22 approx 1511 I arrived at 305 NE 61st Ave APT D13. I knocked on the door several times with no answer. My business card was no longer in the door. I was able to see the window that lead into the apartment and did not see anyone in the apartment. I attempted to look up the cat owner name and address through True People search and could not find any contact information. I did not leave my business card in the door as I am going into my weekend. As I am going to my weekend, I will flip this call into an awaiting assignment for the following district officer to see if they can make contact with the cat owner.

Apr 1 2022 2:01PM On 4.1.22 I arrived at 305 NE 61 Avenue APT D13, PORTLAND OR 97213. The party would not come to the door, case continues

Apr 6 2022 2:07PM 04.06.22 approx 1332 I arrived at 305 NE 61st ave APT D13. I was greeted by ERIKA MEYER (971 888 1202). I informed ERIKA of the complaint. ERIKA allowed me inside of the apartment and attempted to look for her cat. ERIKA stated that her cat "Roxie" was a feral cat and often hides when company is over. ERIKA talked about her documenting "Roxie's" itching, as it comes and goes. ERIKA stated that she has taken the cat to Viva Vet Care twice in the last few months and the vets have suggested taking the cat to a dermatologist. ERIKA stated that she believes her and her cat are attacked with directed energy by the FBI and it is centered from people in the community who wish to harm her. ERIKA stated that she has been thinking of taking the cat to the vet again as she fears the cuts will get infected. I asked ERIKA if she would be able to send me current photos of the cat, as it would not be seen during my visit. ERIKA stated she would, and had stated she had sent me an email last week regarding "Roxie." I informed ERIKA I had not received it and I gave her my correct email. ERIKA stated she would forward the original message to me and once I replied back, she could send me current photos of the cat. I thanked ERIKA and departed. As I have gotten in contact with the owner, I will wait for the email and attach it to this job and follow up with the owner when I return to work on Sunday.

Apr 11 2022 2:04PM 04.11.22 approx 1403 I called Viva Pet Care (503) 886-8678 and left a VM to request the medical information for "Roxy".

Apr 13 2022 04.12.22 approx 1510 I called Viva Pet Care (503) 886-8678 and requested the medical information for "Roxy" I gave my email and the receptionist stated they would email me the information.

1:19PM

Apr 13 04.13.22 I called the cat owner, ERIKA MEYER and asked if she could contain her cat "Roxy" so that
 2022 I may look at the cat's ears. ERIKA stated that was fine and she would meet me at the front door. I
 1:30PM arrived at 305 NE 61st ave APT D13. I greeted ERIKA and "Roxy" and noted the cat was very
 nervous at my presence. I was able to peer into the cat's ears and but was unable to take any decent
 photos as the cat was squirming and uncomfortable. I noticed many red marks/scratches and several
 lumps that appeared to be scabs. I did not note any ear mites or bug like creatures in the ear as
 reported by the PRs last document. I informed ERIKA that I respected her and her beliefs but due to
 the degree of harm to the cat's ears, I stated the cat should be seen by a vet. ERIKA stated she
 understood and stated that she would not be able to fix the damage as she believed it was "directed
 energy" harming her cat. ERIKA did agree to take the cat to her vet as it had "Flared up" and ERIKA
 stated she does take the cat back to the vet for medication when the scratches are extensive. I
 informed ERIKA I would follow up next week on the status of "Roxy's" visit. I thanked ERIKA and
 departed. I called the PR, COURTNEY MAKAL (813 846 9675) and left a VM informing them of the
 status of the case. I informed them to call me if they had any questions or concerns.

May 1 05.01.22 I have been emailing the cat owner, ERIKA MEYER (971 888 1202) since 04.14.22 as
 2022 ERIKA was claiming VIVA PET CARE was refusing care for her cat due to past disagreements on
 9:51AM past care. (medical documents added in job). I had CHIEF JEANNETTE FARRALL for the shelter to
 assist with vet care. But as ERIKA refused care without her being present for the appointments, I
 provided a few email links and phone numbers to low income and close proximity vets to ERIKA. I
 suggested PAWS TEAM and ERIKA stated she sent in a request and form to see she was eligible on
 04.27.22. On 04.29.22 I received an email from ERIKA with a forwarded appointment for "Roxy" at
 Banfield on 05.18.22. I emailed ERIKA on 05.01.22 stating that I would also be in contact with Paws
 Team for her eligibility for any future care for "Roxy." I emailed Paws Team and requested contact.

May 2 05.02.22 as ERIKA has an appointment for her cat, I will close this complaint and reopen if the Paws
 2022 Team reaches out to me.

Hi, I sent in a report i think last week about a woman named Erika Meyer and her refusal to take her cat, Roxy, to the vet. Through videos she's made on her own channel, she's stated that you guys left a note on her door, and I think she's sent you an email. She claims that there are no insects in the apartment, but while she was recording Roxy's ears, I saw a HUGE bug in her ear that Erika directly films. Originally I thought it was a scab but later confirmed it's indeed moving and wasn't there before. I've attached a photo of the ear (where the insect seems to be), and have linked others at the end of this message that show the blob is indeed moving and alive. I'm extremely worried about the cat now that I've seen the bugs with my own eyes and not just the injuries. Please Please Please keep on Erika and rescue this cat. I know erika genuinely cares about Roxy but she is so far into delusion that she refuses totake her to the vet to get treated. I'm sending this in through here because I already made an official report and don't know who to email about this case - but if you want me to create another report, please let me know and I absolutely will.

Thank you so much for already starting to check on her, but given how HUGE this insect was and how much Roxy is bleeding and how much Erika is insisting that its directed energy weapons and that "the vet can't help because it's directed energy and not insects" when theres an insect right in front of her, i couldn't let this development go unreported.

May 5 2022 12:30PM The cat's owner--Erika Meyer--is VERY mentally ill--delusional disorder diagnosis--bipolar--schizoid effective. She believes she has been implanted with devices by the FBI CIA DOJ or UNKNOWN ENTITY --she believes the are using Direct Energy Weapons in an attempt at mind control and to assassinate her. Last year (May 2021) she was documented by adult protective agency as an abuser of a vulnerable terminally ill elderly human. She believed the same things were happening to the person she abused. She is now saying the Roxy's Ears (the cats) have been implanted with devices and that she (Roxy) is being injured with direct energy weapon. The ears are freshly bleeding--look raw and gouged. Erika also has a documented history of Self-Flagellation and is often COVERED head to toe in giant bruises --burns--marks that she claims are caused by Direct Energy Weapons. May 6 2022 4:03PM In the attached video the owner, ERIKA shows the cat "Roxy" ears. Which appear to be very red as the cat actively was scratching them. ERIKA stated in the video that she did not do this to her cat, the FBI did. ERIKA stated that she had taken her cat to the vet, but the cat is still suffering due to the FBI continuing to do this to "Roxy". I arrived at the provided address at approx 1540hrs and located unit D13. The unit is the closest to the parking lot in the back of the building. All units were individually marked units, except for D13 which had a shared front door with 14. I left a low cost resource guide and my b/c with D13 written. I taped it directly under the unit marker for D13.

May 7 2022 2:53PM On 5/7/22 at approx 1500hrs I arrived at the complex and noted that my bc and low cost resource guide had been removed from the door. I knocked on the shared door for D13/14 and received no response. Left 2nd b/c

May 13 2022 9:43AM As of 5/13/22 I have not heard back from Erika to assist if any vet care is needed for "Roxy". In the video it was noted that Erika had taken the cat to a unknown vet.

May 13 2022 4:09PM On 5/13/22 I arrived at the provided address at approx 1610hrs. I knocked on the shared door and received no response. I left a third B/C addressed to Erika unit D13.

May 13 2022 4:19PM I called MCAS disabilities office at 503-988-3658 and lvm to a IDD manager, Alley. To inquire if Erika Meyer has a case worker as she has not responded to my attempts to contact

May 14 2022 8:09AM NOTE: Pending call from Adult Protective Services for assistance as A/O is not responding to my attempts for contact

May 18 2022 10:34AM I received a call from Allie with IDD and APS. Allie stated that she could not find Erika Meyer in the system as having a case worker. I consulted Lead Wammack as our only source of evidence is the video and I have provided low cost resource options with numerous attempts to contact the owner, I will close this case at this time.

ERIKA stated that she still believed the attacks were caused by directed energy and were hurting her cat. ERIKA expressed the need to find a lab to find devices she believed to be in the cat's ears. I informed ERIKA that MCAS did not provide a service such as that but she could speak to my supervisor for other options. To Whom It May Concern:

I am writing to report a crime. Although this crime centers around corruption, it involves a lot of violence enacted through institutions such as police and medical systems, presumably for the purpose of control, retaliation and in order to keep a system of human trafficking and medical fraud afloat. So I personally think it also fits the definition of terrorism as well - corruption being a means to enact terror. I would like to do a full interview with the FBI; I tried this once on January 25, 2015 but the officer I met behaved very strangely, and in fact appeared to be acting on behalf of the criminal network, so I was unsuccessful.

The core of this crime is human trafficking, including child trafficking, via hidden camera surveillance devices which are possibly placed, and definitely protected, by police and fire departments. These surveillance devices are in public restrooms, gym locker rooms, public schools, in our home, and even in our body (via covertly placed radio frequency monitoring and manipulation implants). I have reason to believe that along with me and my partner, my daughter has been, and is increasingly being trafficked in this way. I believe she is also being blacklisted and set up with fraudulent "honeypot" boyfriends in order to better control and exploit her.

I am "wired" head to toe with radio-frequency activated medical implants. I've used a bug detector to find them in many different locations in my body, including in my head, teeth, neck, ears, eyes, all mucous membranes, in my gut, and near my heart. Frequently these devices are used to torture me with severe pain; they also create other illnesses. I've also be burned with microwaves, at one time, I was burned daily for months.

I have received assistance through some of these devices from military (probably Army) intelligence in the form of scripted, coded dreams, and different types of telepathy (frequency-based mind control). Mostly what I've gotten is information, and frequently, warnings about specific attacks being planned for people in my life, most often me, my partner Chris, and my daughter.

I've uncovered numerous other crimes related to this, including many instances of

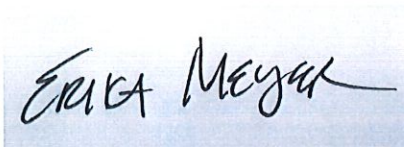
deliberately created illnesses, including cancers, and linked murders. My YouTube channel explains some of what I have uncovered.

Meanwhile, I've been dealing with a lot of targeted evidence destruction, with evidence being removed from my hard drive, from back up drives, and from cloud storage (Google accounts) simultaneously. I believe this is linked to police, though it seems to be done on behalf of others in the network.

I have reason to suspect the FBI, or at least certain branches of the FBI, has been involved in this crime in the past. I believe this was deliberately planned in order to hobble the FBI's ability to enforce the law and bring an end to the crime. But there must be a way around this. I would forgive the FBI for past involvement if it would act decisively now to end the crime, and I'm sure that Chris and my daughter would feel the same way. I know this crime is harming many people around the country if not the world, and so is likely harming national security as well.

Thanks Megan. I can be here whenever you want as long as I know ahead of time. First thing in the morning is fine. Just give me a time and we'll be here with bells on.

You know, no one but me sees Roxy. I live alone, no one comes over, and she's an indoor cat. The likely or at least most obvious reason people know what is going on is that I've been documenting and posting video and photos online. These frequency based attacks occur in waves, and are usually worse at night. It was getting really bad and I was posting to try and call attention to it, to bear witness in hopes maybe someone could or would take action on our behalf.

Roxy's been suffering for months. I am in contact with the Paws group right now but as you know this is a complex issue and it seems far more difficult than it needs to be to assess the veracity of what I am claiming is actually going on. This is one of the many reasons I suspect widespread financial malfeasance. So I post photos and video hoping to catch the attention of a courageous person who can see she's suffering, and deserves relief and/or an honest scientific assessment. If I could get someone to do a proper assessment I believe I could find the proper funding to pay for lab time, and a lab tech. It would likely be a biomedical research lab, likely in an educational institution. The problems I believe are not scientific but political.

I have been using Tresaderm on Roxy's ears since June 31 and the attacks have lessened since June 30, so at this time she is improving.

Will forward my latest correspondence to the PAW's team.

See you on Tuesday at the time of your choosing.

Camilla, Thank you. I went to Banfield 82nd. I do not believe they were honest with me about the tests they gave her, claiming she had a yeast infection, which I doubt. They didn't show evidence, and I don't believe they really tested her for yeast. Regardless, the treatment they recommended was inappropriate. They did not listen to evidence about how Roxy's problems manifest that did not support their out-of-the-box diagnosis. Her ears are literally burnt and they prescribed an acid-based wash, telling me to use it even though her ears were terribly irritated. I tried it once and before I realized I'd been had - it caused her pain and me trauma.

Roxy is still in a lot of agony. There are patterns around how she is suffering that make me know she is not suffering from allergies but from some kind of biomedical and/or microwave weapons attacks. They said I should go to a dermatologist to totally eliminate the possibility she's got allergies. That vet claimed that a dermatologist could tell 100% whether the cat has allergies. I have my doubts. I think she should be tested for wirelessly activated piezoelectrical biomedical devices if not at a vet, then by biomedical researchers who have access to the correct equipment such as PowerLab Data Acquisition systems. This would be, potentially, a place like OHSU biomedical research laboratories. I sent an inquiry to OHSU lab directors (attached) and did not receive a response, but possibly if someone in a more official capacity were to initiate communications, they would be more successful. I have a lot of photographic and narrative-based evidence that there is something very unusual going on, and there are in fact signs it is wireless attacks through biomedical implants.

I'd be willing to fundraise whatever money is necessary to pay for lab time and a lab tech. Mostly I think it's important for a credible professional to verify what her actual symptoms are and whether or not she's got some type of implanted device giving off wireless signals which are used as a target for directed energy devices and/or wireless applications. She has had problems in her legs - and weirdly, sometimes simultaneously with me having the same sort of problems in my legs. I've also had skin issues (itchy rash-like burns) similar to hers. I can show photos of the injuries, and I can show video of her crying out in pain during a wireless attack.

For a number of reasons, based on my observations, and things that have happened to other pets of mine, I do not think she's the only animal in Portland suffering this way.

Piezoelectrical implants can be extremely small and/or thin (as small as 1mm or less in diameter), with thin-film electrodes just microns thick, so it is possible that an x-ray (for example, of her ears) could reveal something. But the reality is, based on my research, the best way to locate these is with the proper equipment which would scan for wireless frequencies (likely on biomedical or military bands) and this would be in the possession of biomedical research facilities.

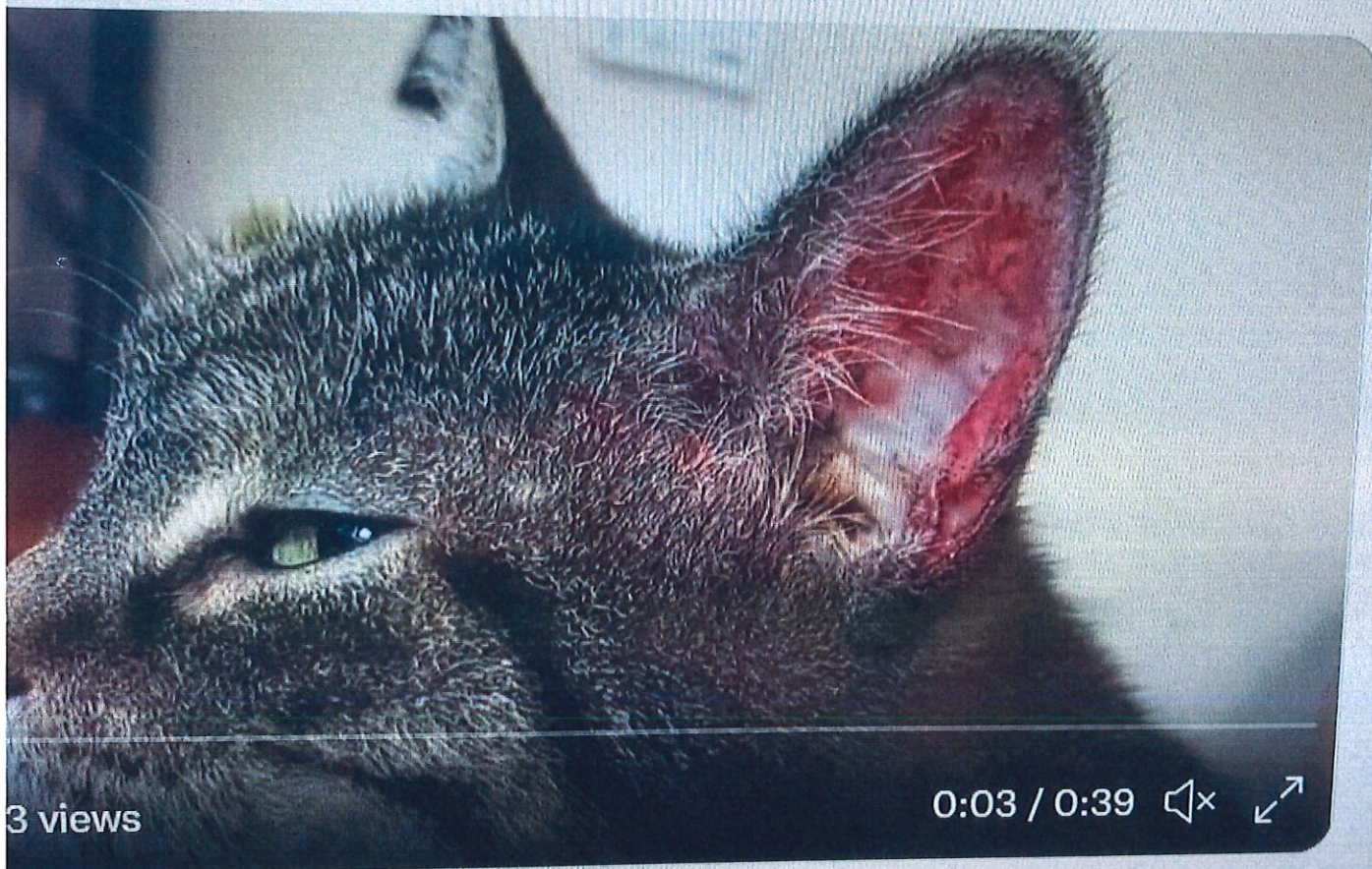

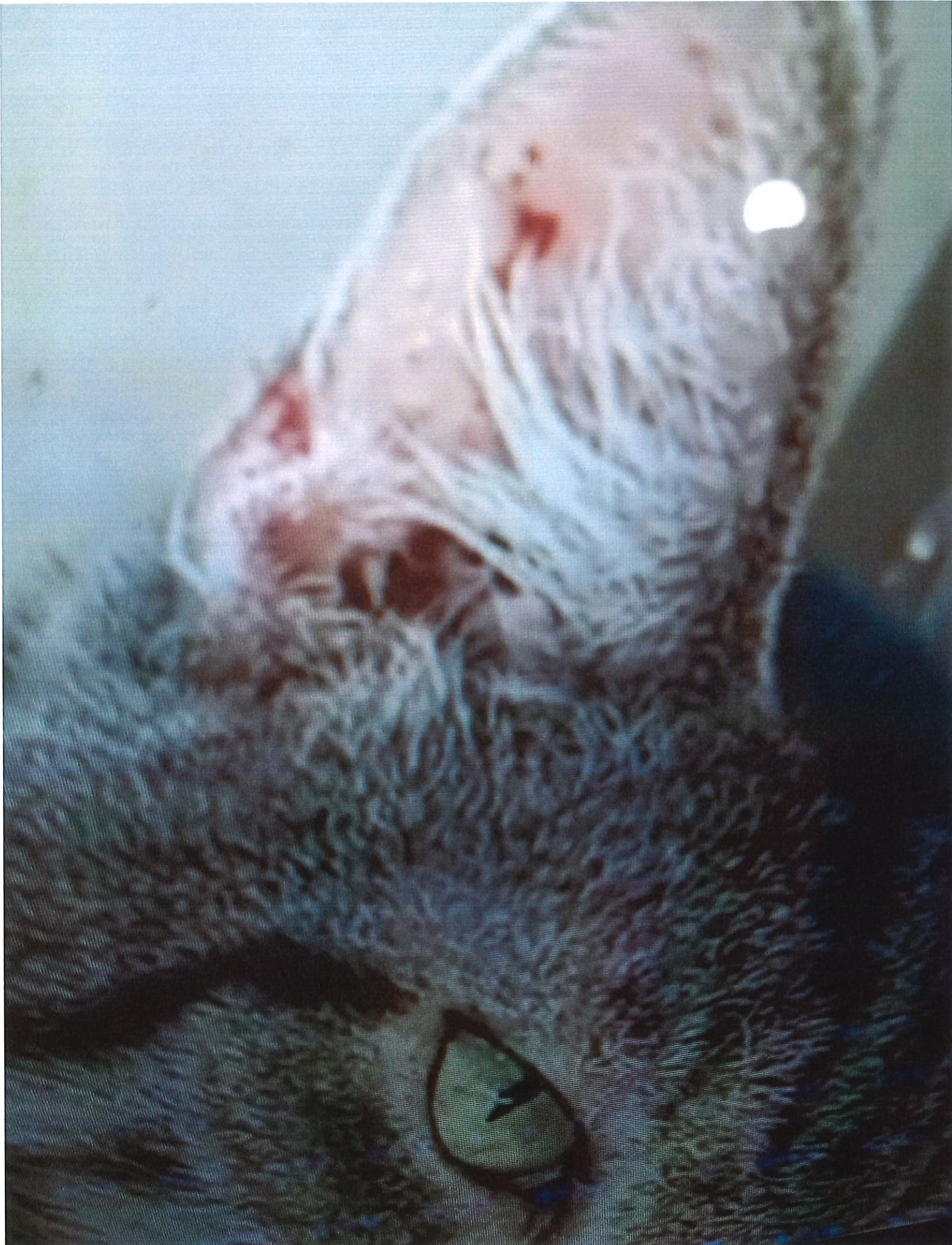
